# NOTICE OF VARIATION OF AMATEUR RADIO LICENCE

The Secretary of State hereby gives notice pursuant to section 1(4) of the Wireless Telegraphy Act 1949 to holders of the Amateur Radio Licence (A) or (B) ("the Licence") that, from 2nd August 1999, each licence shall be varied as follows:

1; In this Notice, "the Booklet" means the Terms, Provisions and Limitations Booklet BR68, the terms of which form part of the Licence. 2. As and from 2nd August 1999, the licence shall be read and construed as if:

(1) the words "OR (A/B)" were inserted after "AMATEUR RADIO LICENCE (A)" in the title to the Booklet;
(2) the words "or (A/B)" were inserted after "Amateur Radio Licence

(A)" in the introductory sentence to the Booklet;

(3) a new clause 2(1A) were inserted in the Booklet after clause 2(1): "2(1A) If the Licence is an Amateur Radio Licence (A/B), then the Licensee shall only use a power not exceeding 20 dBW when transmitting in the frequency bands 1.810-1.850 MHz and in the bands at or above 3.500 MHz and below 30 MHz specified in the first column of the Schedule.":

(4) the words "In the case of an Amateur Radio Licence (A/B), authorise any club member who holds an Amateur Radio Licence (A/B) or (B) to use and supervise the operation of the Station on his behalf under this Licence." were inserted after the first sentence in clause 2(19)(a);

(5) the words "an Amateur Morse" were deleted from clause 3(1)(b) of the Booklet and replaced by "a twelve words per minute Amateur Morse":

(6) the word "or" was deleted from the end of clause 3(1)(b) of the Booklet and replaced by "and";

(7) a new clause 3(1)(c) were inserted in the Booklet as follows: (c) in the case of an Amateur Radio Licence (A/B), a 5 words per minute Amateur Morse Test Pass Slip issued on behalf of the Secretary of State: or"

and "(d)" were inserted at the beginning of the next line;

(8) the words "(A/B) or" were inserted after the words "Amateur Radio Licence" in clause 11(1)(f) of the Booklet;
(9) the words "(A) and (B)" were deleted from the title to the

Schedule to the Booklet and replaced by "(A) or (A/B) or (B)"; (10) Note (b) of the Schedule to the Booklet were deleted and replaced by:

"(b) In all frequency bands, high intensities of RF radiation may be harmful and safety precautions should be taken, particularly in locations to which people have access. Advice concerning safe levels of exposure to RF radiation is provided by the National Radiological Protection Board."; and
